Modern Day Slavery and Human Trafficking Statement

Our Business and Supply Chain Structure

We utilize 3rd party providers for hosting digital group sessions, who are trained mental health professionals.

Policies in Relation to Modern Slavery and Human Trafficking

1. **Code of Conduct:** Our Code of Conduct clearly outlines the expectations we have of our employees and business partners concerning ethical behavior and compliance.

We invest in educating our staff and partners about the risks of modern slavery and human trafficking. Regular training sessions ensure that our team is well-equipped to identify warning signs and take appropriate action if they suspect any violations.

We recognize the importance of continuous improvement and annually review our policies and strategies to combat modern slavery. We encourage transparency and open dialogue with our stakeholders, including our customers, suppliers, and the general public, to uphold our commitment.
